What if I don't see my name on the Congratulations List?

If you don't see your name on this list, then you are out of SIEDRS compliance and will receive a separate non-compliance notification shortly.

Each month for which claims data is not submitted counts as a non-compliance "occurrence." We will start counting occurrences in November and will begin collecting penalties in February 2009 after the SIEDRS rule becomes effective. For example, if you do not submit claims data to SIEDRS through February, you will have four occurrences and be penalized \$2,000. Because the system and its requirements are new, we have decided to waive penalties for August, September, and October submittals.

You are still required to submit all claims data beginning with July 2008.
